- I. Meeting was called to order by Dr. Daniel King, Chairman, at 12:02pm
- II. Present were:

- III. Proposal to approve the minutes from the May 2018 meeting. Motion was made by Dr. Gutierrez to approve the minutes; 2<sup>nd</sup> by Mr. Ramirez – **motion passes**. The minutes from the May 25, 2018 meeting were approved.
- IV. New Business (Action Items)
  - a. 2018 UIL Pigskin Report
    - i. Motion to approve 2018 Pigskin Report – Motion made by Mr. Ramirez, 2<sup>nd</sup> by Dr. Vidaurri – **motion passes** to approve 2018 Pigskin Report.
  - b. Selection of Pigskin Sites for 2019
    - i. Motion to continue rotation for the East Zone. EZ at Edinburg CISD and to keep West Zone at Mission ISD for another year – Motion made by Mr. Guzman, 2<sup>nd</sup> by Mr. Ramirez – **motion passes** for East Zone Pigskin to be at ECISD and West Zone Pigskin to be at Mission ISD.
- V. New Business (Discussion Items)
  - a. Mr. Adame reminded the Executive Committee that at the end of 2020 school year, all UIL Regions will only be allowed to keep 25% of their 2 year average operating cost in the UIL Bank Account. Anything over the 25% will be reimbursed back to the school districts in our Region.

  - c. Mr. Adame informed the Executive Committee that any check written by UIL that went over \$5000 would require 2 signatures.
